I hereby revoke any and all proxies heretofore made by me, and hereby expressly declare that the proxy herein given shall continue to remain in effect until revoked by me by a written notice by registered or certified mail, return receipt requested, addressed to the Secretary of the Credit Union address, or at such other address or location to which the offices of the credit union may be subsequently removed.
